GENERAL TERMS & CONDITIONS:

- (1) Tenders forms shall be issued to those contractors / firms who deposited their enlistment/registration fee & renewal fee.
- (2) The tenders should be free from cutting/overwriting etc.
- (3) The tender forms alongwith tender documents can be obtained from this office on payment (non-refundable) as mentioned against each on or before 13-10-2020 upto **1200 hours sharp**.
- (4) The tender form shall be issued on submission of call deposit equivalent to 2% of the total estimated cost of the each project.
- (5) Tender should be submitted in a sealed envelope and the work for which tender is being given should be mentioned clearly on envelop.
- (6) The tender shall be cast in the tender box on 14-10-2020 upto **1400 hours** and shall be opened on the same day at **1430 hours** in the presence of tenderers or their authorized representatives, who may like to be present.
- (7) Conditional tender and tender without call deposit shall not be entertained.
- (8) Rates should be submitted on above or below the MES Schedule of Rates, 2014 (as amended upto date).
- (9) Cantonment Board Peshawar reserves the right to demand the analysis of the quoted rates from the concerned bidder, to check their reasonability and workability.
- (10) In case if the lowest tendered rate is less than reasonable rates, the lowest bidder shall have to deposit Standing Security (refundable after successful completion of the work) @ 12% of the estimated cost in shape of call deposit within 07 days. In case of failure the already deposited 5% earnest money shall be forfeited and the tender will be cancelled/re-invited.
- (11) The quoted rates shall be valid till the completion of work and in any case no escalation shall be admissible on any pretext.
- (12) The successful contractors / firms for annual maintenance / repair works shall be bound to execute the works as per approved rates till the approval of new rates for the year 2021-22.
- (13) The successful party/firm shall execute a contract agreement (at its own expense) with Cantt Board Peshawar which shall include additional prescribed terms & conditions and the same shall be binding on both the parties for faithful execution of the contracts.

- (14) Work orders would be issued to only those contractors who entered into an agreement with Cantt Board Peshawar on the acceptance of offered rates.
- (15) The contractor shall not assign or sublet the contract in any case. If contractor/firm found involved at any stage shall be liable to cancellation of contract at his/their own risk and cost and the already deposited 2% earnest money shall be forfeited. The case for blacklisting of contractor/firm shall also be placed before the Board.
- (16) All Govt. taxes shall be deducted from the bill as per rules.
- (17) Cantonment Board Peshawar shall not supply any kind of material and machinery to the contractors.
- (18) The successful contractor / firm will have to complete all material / lab tests from University of Engineering & Technology, Peshawar OR Military College of Engineering, (Lab Section), Risalpur Cantt, before processing of bills at his/their own expenses.
- (19) Cantonment Executive Officer/Cantonment Board reserves the right to accept or reject all tenders (prior to approval) as per rule 33(1) of PPRA Rules 2004.
