An estimate amounting to Rs.33.374 (M) for construction of Block-D (ground floor + first floor), Commercial Complex (Al-Nafa Markaz), Shoba Bazar, Peshawar Cantt was approved by the Competent Financial Authority during the year 2016-17. After completion of all necessary legal & codal formalities, the work was awarded to M/s Hidayat Construction on their lowest rates i.e. 9.99% below on MES Schedule of Rates, 2014.

During the course of construction, it was been observed after excavation at site that the area comprising of rubble and not suitable for the ordinary construction which were proposed in the approved estimates. The site was inspected by the Structural Engineer as well as Architect M/s Mascot Consultants and it was decided to change the foundation design with addition of stone boulders & extra steel in foundation, resultantly, the estimated cost needs to be revised. It is pertinent to mention here that at the time of approval soil bearing capacity was not conducted at site and after approval of estimate the soil bearing report was obtained which reflects that the soil is weaken to bear the load of structure on isolated footing and need to be converted into raft foundation, resultantly the major revision of cost is needed.

Meanwhile, during construction the ground floor height was also increased from 11'-0" to 14'-0" as per actual façade of the project due to this change the cost effect amounting to Rs.2.363 million was also increased which needs to be recovered from the bidders i.e. Rs.5.20 million as resolved by the Board vide CBR No. 28, dated 30-11-2017.
