Bidding procedure will be single stage-two envelopes as per Rule 36(b) of PPRA Rules,2004 which envisages as under.


**3). Single stage-two envelop procedure:-**

The Bid shall comprise a single package containing two separate envelopes. Each envelopes shall contain separately the financial proposal and the technical proposal (along with samples of chairs only). The envelopes shall be marked as "FINANCIAL PROPSAL" and TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion. Technical proposal shall be accompanied by a sample of chairs only (sr. no 1).

4). Bidding documents, containing detailed terms and conditions, method of procurement, procedure for submission of bids, bid security, bid validity opening of bid, evaluation criteria, clarification / rejection of bids , performance guarantee etc are available for the interested bidders at Cantonment Board Office, Jalil Road, Peshawar Cantt.
